In matters not regulated in the agreement shall apply, in the following order: (1) Terms and Conditions of Providing Forwarding Services (hereinafter: OWU) applied by the Freight Forwarder available at www.unilog.eu (2) General Polish Forwarding Rules of 14 January 2010. (hereinafter referred to as OPWS) or any subsequent version thereof, which will be accepted after the date of conclusion of the contract, (3) relevant provisions of the Civil Code. The Client declares that he is familiar with the **OWU and OPWS** (4) The Customer renounces cargo insurance, being aware of the limited liability of the shipowner, carrier and freight forwarder according to the above mentioned General Polish Forwarding Conditions. (5) The Customer declares that the goods are of no strategic importance in the meaning of the Act of 29 November 2002 on foreign trade in goods, technologies and services of strategic importance for national security, as well as for maintaining international peace and security. (6) In case the Customer withdraws from the contract or terminates it for reasons other than the Freight Forwarder's fault, he is obliged to pay to the Freight Forwarder the contractual penalty of 150 EUR. The payment of the contractual penalty does not exclude the right to claim damages under the general rules.
